

- **Q. 1** A cubic vessel (with face horizontal + vertical) contains an ideal gas at NTP. The vessel is being carried by a rocket which is moving at a speed of 500 m s^{-1} in vertical direction. The pressure of the gas inside the vessel as observed by us on the ground
 - (a) remains the same because 500 ms⁻¹ is very much smaller than $v_{\rm rms}$ of the gas
 - (b) remains the same because motion of the vessel as a whole does not affect the relative motion of the gas molecules and the walls
 - (c) will increase by a factor equal to $(v_{rms}^2 + (500)^2) / v_{rms}^2$ where v_{rms} was the original mean square velocity of the gas
 - (d) will be different on the top wall and bottom wall of the vessel
 - Thinking Process This phenomenon is based on the concept of relative motion that is when collision takes place, it is the relative velocity which changes.
- Ans. (b) As the motion of the vessel as a whole does not effect the relative motion of the gas molecules with respect to the walls of the vessel, hence pressure of the gas inside the vessel, as observed by us, on the ground remains the same.



Q. 2 1 mole of an ideal gas is contained in a cubical volume *V*, *ABCDEFGH* at 300K (figure). One face of the cube (*EFGH*) is made up of a material which totally absorbs any gas molecule incident on it. At any given time,




- (a) the pressure on EFGH would be zero
- (b) the pressure on all the faces will the equal
- (c) the pressure of EFGH would be double the pressure on ABCD

Ans. (*d*) In an ideal gas, when a molecule collides elastically with a wall, the momentum transferred to each molecule will be twice the magnitude of its normal momentum. For the face *EFGH*, it transfers only half of that.


So, this process can be called as isothermal process.

Q. 4 A cylinder containing an ideal gas is in vertical position and has a piston of mass *M* that is able to move up or down without friction (figure). If the temperature is increased

- **Ans.** *(c)* Consider the diagram where an ideal gas is contained in a cylinder, having a piston of mass *M*. Friction is absent.



The pressure inside the gas will be

 $p = p_a + Mg/A$

where, p_a = atmospheric pressure

A = area of cross-section of the piston.


Mg = weight of piston

Hence, p = constant.

When temperature increases

as $pV = nRT \Rightarrow$ volume (V)increases at constant pressure.

Q. 5 Volume versus temperature graphs for a given mass of an ideal gas are shown in figure. At two different values of constant pressure. What can be inferred about relation between p₁ and p₂?



To find the required relation, we have to consider slope of the V - T graph. By ideal gas equation, the slope of V-T curve is V/T = nR/p. This imply that greater the slope, smaller the pressure and vice-versa.

Ans. (a) We know for an ideal gas,


$$pV = nRT \Rightarrow V = \left(\frac{nR}{p}\right)T$$
Slope of the V – T graph, $m = \frac{dV}{dT} = \frac{nR}{p}$ [m = slope of V – t graph]
 $\Rightarrow \qquad m \propto \frac{1}{p}$ [: nR = constant]
 $\Rightarrow \qquad p \propto \frac{1}{m}$
hence, $\frac{p_1}{p_2} = \frac{m_2}{m_1} < 1$ [$P = \text{pressure}$
 $V = \text{volume}$
 $n = \text{number of moles of gases}$
 $R = \text{gas constant}$
 $T = \text{temperature}$]

where, m_1 is slope of the graph corresponding to p_1 and similarly m_2 is slope corresponding to p_2 .

 \Rightarrow $p_2 < p_1$ or $p_1 > p_2$

Q. 6 1 mole of H_2 gas is contained in a box of volume $V = 1.00 \text{ m}^3$ at T = 300 K. The gas is heated to a temperature of T = 3000 K and the gas gets converted to a gas of hydrogen atoms. The final pressure would be (considering all gases to be ideal)


- (a) same as the pressure initially (b) 2 times the pressure initially
- (c) 10 times the pressure initially
- (d) 20 times the pressure initially



Now, by ideal gas equation

P = Pressure of gas,n = Number of molesR = Gas constant,T = TemperaturepV = nRT

As volume (V) of the container is constant.



As gases breaks number of moles becomes twice of initial, so $n_2 = 2n_1$ So, $p \propto n T$

$$\Rightarrow \qquad \frac{p_2}{p_1} = \frac{n_2 T_2}{n_1 T_1} = \frac{(2n_1)(3000)}{n_1(300)} = 20$$
$$\Rightarrow \qquad p_2 = 20p_1$$

Hence, final pressure of the gas would be 20 times the pressure initially.

Q. 7 A vessel of volume *V* contains a mixture of 1 mole of hydrogen and 1 mole oxygen (both considered as ideal). Let $f_1(v)dv$, denote the fraction of molecules with speed between *v* and (v + dv) with $f_2(v)dv$, similarly for oxygen. Then,

(a) $f_1(v) + f_2(v) = f(v)$ obeys the Maxwell's distribution law

(b) $f_1(v)$, $f_2(v)$ will obey the Maxwell's distribution law separately

Ans. (b) For a function f(v), the number of molecules n = f(v), which are having speeds between v and v + dv.

For each function $f_1(v)$ and $f_2(v)$, *n* will be different, hence each function $f_1(v)$ and $f_2(v)$ will obey the Maxwell's distribution law separately.

Q. 8 An inflated rubber balloon contains one mole of an ideal gas, has a pressure *p*, volume *V* and temperature *T*. If the temperature rises to 1.1 T, and the volume is increased to 1.05 *V*, the final pressure will be

Ans. (d) We know for an ideal gas, $pV = nRT$ (Ideal gas equation)
 \Rightarrow $n =$ Number of moles, $p =$ Pressure, $V =$ Volume
 $R =$ Gas constant, $T =$ Temperature
 $= \frac{pV}{RT}$

As number of moles of the gas remains fixed, hence, we can write

$$\frac{p_1 V_1}{RT_1} = \frac{p_2 V_2}{RT_2}$$

$$p_2 = (p_1 V_1) \left(\frac{T_2}{V_2 T_1}\right)$$

$$= \frac{(p) (V) (1.1 T)}{(1.05) V(T)} \qquad \left[\begin{array}{c} p_1 = p \\ V_2 = 1.05 V \text{ and } T_2 = 1.1 T \end{array}\right]$$

$$= p \times \left(\frac{11}{1.05}\right)$$


$$= p (1.0476) \approx 1.05 p$$

Hence, final pressure p_2 lies between p and 1.1p.

Q. 9 *ABCDEFGH* is a hollow cube made of an insulator (figure) face *ABCD* has positive charge on it. Inside the cube, we have ionised hydrogen.

The usual kinetic theory expression for pressure



(a) will be valid

- (b) will not be valid, since the ions would experience forces other than due to collisions with the walls
- (c) will not be valid, since collisions with walls would not be elastic

Thinking Process As ionised hydrogen is present inside the cube, they are having charge. Now, due to presence of positive charge on the surface ABCD hydrogen ions would experience forces of electrostatic nature.

Ans. (b, d)

Due to presence of external positive charge on the face *ABCD*. The usual expression for pressure on the basis of kinetic theory will not be valid as ions would also experience electrostatic forces other than the forces due to collisions with the walls of the container. Due to presence of positive charge the isotropy is also lost.

Consider a diatomic molecule as shown in the diagram. The total energy associated with the molecule is

$$E = \frac{1}{2}mv_x^2 + \frac{1}{2}mv_y^2 + \frac{1}{2}mv_z^2 + \frac{1}{2}I_x\omega_x^2 + \frac{1}{2}I_y\omega_y^2$$

This above expression contains translational kinetic energy $\left(\frac{1}{2}mv^2\right)$ corresponding to velocity in each *x*, *y* and *z*-directions

as well as rotational $KE\left(\frac{1}{2}I\omega^2\right)$ associated with axis of rotations




The number of independent terms in the above expression is 5.


As we can predict velocities of molecules by Maxwell's

distribution, hence the above expression also obeys Maxwell's distribution.

 \therefore 2 rotational and 3 translational energies are associated with each molecule.

Thinking Process The elastic collisions of the molecules with a moving part of two system increases their energy.

Ans. (*a*) When the gas is compressed adiabatically, the total work done on the gas increases its internal energy which in turn increase the KE of gas molecules and hence, the collisions between molecules also increases.

Q. 14 Calculate the number of atoms in 39.4 g gold. Molar mass of gold is 197g mole⁻¹.

Ans. We know that,

Molar mass = Mass of Avogadro's number of atoms (Molecules).= 6. 023 × 10^{23} atoms.Given, molar mass of gold = 197 g/molNow, \therefore 197 g of gold contains = 6.023×10^{23} atoms \therefore 1 g of gold contain = $\frac{6.023 \times 10^{23}}{197}$ atoms \therefore 39.4 g of gold contains = $\frac{6.023 \times 10^{23} \times 39.4}{197} \Rightarrow 1.20 \times 10^{23}$ atoms.

Q. 15 The volume of a given mass of a gas at 27°C, 1 atm is 100cc. What will be its volume at 327°C ?

Ans. We have to convert the given temperatures in kelvin . If pressure of a given mass of the gas is kept constant, then

 $\begin{array}{l} \Rightarrow & \begin{array}{c} V \propto T \\ \frac{V}{T} = \text{constant} \\ \frac{V_1}{T} = \text{constant} \\ \frac{V_1}{T_1} = \frac{V_2}{T_2} \\ \Rightarrow & \begin{array}{c} V_2 = V_1 \left(\frac{T_2}{T_1}\right) \\ \frac{T_1 = 273 + 27 = 300 \text{ K}}{T_2 = 273 + 327 = 600 \text{ K}} \\ \frac{T_2 = 273 + 327 = 600 \text{ K}}{V_1 = 100 \text{ cc}} \\ \frac{V_2 = V_1 \left(\frac{600}{300}\right)}{V_2 = 2V_1} \\ \therefore & \begin{array}{c} V_2 = 2V_1 \\ V_2 = 2 \times 100 = 200 \text{ cc} \\ Note To apply ideal gas equation, we must convert the given temperature in kelvin. \end{array}$

- Q. 16 The molecules of a given mass of a gas have root mean square speeds of 100 ms⁻¹ at 27°C and 1.00 atmospheric pressure. What will be the root mean square speeds of the molecules of the gas at 127°C and 2.0 atmospheric pressure?
- Ans. We know that for a given mass of a gas

$$v_{\rm rms} = \sqrt{\frac{3RT}{M}}$$

where, R is gas constant T is temperature in kelvin M is molar mass of the gas. Clearly , $v_{\rm rms} \propto \sqrt{T}$

As R, M are constants,

Ans. O_2 is a diatomic gas having 5 degrees of freedom. $\begin{bmatrix} R = \text{Universal gas constant} \\ T = \text{temperature} \end{bmatrix}$ Energy (total internal) per mole of the gas = $\frac{5}{2}$ RT For 2 moles of the gas total internal energy = $2 \times \frac{5}{2}RT = 5RT$...(i)

Neon (Ne) is a monoatomic gas having 3 degrees of freedom.

∴ Energy per mole = $\frac{3}{2}RT$ We have 4 moles of Ne. Hence, Energy = $4 \times \frac{3}{2}RT = 6RT$

- **Q.** 21 A gas mixture consists of molecules of *A*, *B* and *C* with masses $m_A > m_B > m_C$. Rank the three types of molecules in decreasing order of (a) average KE (b) rms speeds.
- Ans. (a) The average KE will be the same, as conditions of temperature and pressure are the same.

Now as,

$$v_{rms} = \sqrt{\frac{3\rho V}{M}} = \sqrt{\frac{3RT}{M}}$$

$$= \sqrt{\frac{3RT}{mN}} = \sqrt{\frac{3kT}{m}}$$

- Q. 22 We have 0.5 g of hydrogen gas in a cubic chamber of size 3 cm kept at NTP. The gas in the chamber is compressed keeping the temperature constant till a final pressure of 100 atm. Is one justified in assuming the ideal gas law, in the final state? (Hydrogen molecules can be consider as spheres of radius 1 Å).
 - Thinking Process For justification of assuming the ideal gas law, the molecular volume and the volume occupied of the ideal gas is compared. If both matches, then law holds good otherwise not.
- **Ans.** Assuming hydrogen molecules as spheres of radius 1 Å. So, r = 1 Å = radius.

The volume of hydrogen molecules $=\frac{4}{3}\pi r^3$ $=\frac{4}{3}(3.14)(10^{-10})^3$ $\approx 4 \times 10^{-30} \text{ m}^3$ Number of moles of H₂ $=\frac{\text{Mass}}{\text{Molecular mass}}$ $=\frac{0.5}{2}=0.25$

- Molecules of H₂ present =Number of moles of H₂ present $\times 6.023 \times 10^{23}$
- $\begin{array}{l} \Rightarrow 0.25 \times 6.023 \times 10^{23} \\ \Rightarrow \text{ Molecules present} \\ = \text{ Molecules number } \times \text{ volume of each molecule} \\ = 0.25 \times 6.023 \times 10^{23} \times 4 \times 10^{-30} \\ = 6.023 \times 10^{23} \times 10^{-30} \\ \approx 6 \times 10^{-7} \text{ m}^3 \\ \end{array}$

Now, if ideal gas law is considered to be constant.

Hence, on compression the volume of the gas is of the order of the molecular volume [form Eq.(i) and Eq.(ii)]. The intermolecular forces will play role and the gas will deviate from ideal gas behaviour.

Q. 23 When air is pumped into a cycle tyre the volume and pressure of the air in the tyre both are increased. What about Boyle's law in this case?

Ans. When air is pumped, more molecules are pumped and Boyle's law is stated for situation where number of molecules remains constant.

In this case, as the number of air molecules keep increasing. Hence, this is a case of variable mass. Boyle's law (and even Charle's law) is only applicable in situations, where number of gas molecules remains fixed.

Hence, in this case Boyle's law is not applicable.

Q. 24 A balloon has 5.0 mole of helium at 7°C. Calculate

- (a) the number of atoms of helium in the balloon.
- (b) the total internal energy of the system.

• Thinking Process Energy associated with a monoatomic molecule is $\frac{3}{5}kT$.

Ans. Given, number of moles of helium = 5

 $T = 7 \,^{\circ}\text{C} = 7 + 273 = 280\text{K}$

(a) Hence, number of atoms (He is monoatomic)

= Number of moles ×Avogadro's number

$$= 5 \times 6.023 \times 10^{23}$$

 $= 30.015 \times 10^{23}$

$$= 3.0 \times 10^{24}$$
 atoms

(b) Now, average kinetic energy per molecule = $\frac{3}{2} k_B T$

(It has only 3 degrees of freedom)

Here, k_B = Boltzmann constant. \therefore Total energy of all the atoms

Q. 25 Calculate the number of degrees of freedom of molecules of hydrogen in 1 cc of hydrogen gas at NTP.

Thinking Process

Total number of degrees of freedom in a thermodynamical system = number of degrees of freedom associated per molecule × number of molecules.

Ans. As given molecules are of hydrogen.

... Volume occupied by 1 mole

= 1 mole of the gas at NTP

$$= 22400 \,\text{mL} = 22400 \,\text{cc}$$

...Number of molecules in 1 cc of hydrogen

$$=\frac{6.023\times10^{23}}{22400}=2.688\times10^{19}$$

 H_2 is a diatomic gas, having a total of 5 degrees of freedom (3 translational + 2 rotational) \therefore Total degrees of freedom possesed by all the molecules

$$= 5 \times 2.688 \times 10^{19}$$

$$= 1.344 \times 10^{20}$$

Note Any ideal gas has a molar volume of 22400 mL (cc) at NTP.

- Q. 26 An insulated container containing monoatomic gas of molar mass m is moving with a velocity v_o. If the container is suddenly stopped, find the change in temperature.
 - Thinking Process As the container is suddenly stopped there is no time for exchange of heat in the process.
- Ans. According to kinetic interpretation of temperature, absolute temperature of a given sample of a gas is proportional to the total translational kinetic energy of its molecules. Hence, any change in absolute temperature of a gas will contribute to corresponding

change in translational KE and vice-versa.

Assuming n = number of moles.

Given, m = molar mass of the gas.

When, the container stops, its total KE is transferred to gas molecules in the form of translational KE, thereby increasing the absolute temperature.

If ΔT = change in absolute temperature.

Then, KE of molecules due to velocity

, KE = $\frac{1}{2}$ (mn) v_0^2 ...(i)

Increase in translational KE =

Q. 27 Explain why

(a) there is no atmosphere on moon

- (b) there is fall in temperature with altitude
- **Ans. (a)** The moon has small gravitational force (pull) and hence, the escape velocity is small. The value of escape velocity for the moon is 4.6 km/s.

As the moon is in the proximity of the earth as seen from the sun, the moon has the same amount of heat per unit area as that of the earth.

The air molecules have large range of speeds. Even though the rms speed of the air molecules is smaller than the escape velocity on the moon, a significant number of molecules have speed greater than escape velocity and they escape.

Now, rest of the molecules arrange the speed distribution for the equilibrium temperature. Again a significant number of molecules escape as their speed exceed escape speed. Hence, over a long time the moon has lost most of its atmosphere.

At 300 K,
$$v_{rms} = \sqrt{\frac{3kT}{m}} = \sqrt{\frac{3 \times 1.38 \times 10^{-23} \times 300}{7.3 \times 10^{-26}}} = 1.7 \text{ km/s}$$

 $v_{es} \text{ for moon} = 4.6 \text{ km/s}$ $[v_{es} = \text{escape velocity}]$

(b) As the molecules move higher; their potential energy increases and hence, kinetic energy decreases and hence, temperature reduces.

At greater height more volume is available and gas expands and hence, some cooling takes place.

Note We should not relate temperature directly with potential energy. It is directly related with kinetic energy of the molecules.

Q. 29 Ten small planes are flying at a speed of 150 km/h in total darkness in an air space that is $20 \times 20 \times 1.5$ km³ in volume. You are in one of the planes, flying at random within this space with no way of knowing where the other planes are. On the average about how long a time will elapse between near collision with your plane. Assume for this rough computation that a saftey region around the plane can be approximated by a sphere of radius 10 m.

Thinking Process

To solve this problem, we have to consider the relaxation time as well as mean free path.

Ans. The situation can be considered as the time of relaxation, based on kinetic theory of gases. Mean free path is the distance between two successive collisions, which we will consider here as the distance travelled by the plane before it just avoids the collision safe radius is equivalent to radius of the atom. Hence, the required time


