Preface

Vegetables play a major role in Indian agriculture by providing food, nutritional and economic security and more importantly, producing higher returns per unit area and time. In addition, vegetables have shorter maturity cycle, higher productivity, high value and provide greater income leading to improved livelihood. In our country vegetable production was less than 20 million tones before independence which have now increased to 156.3 million tones from an area of 8.98 million ha. India is the second largest producer of vegetables next to China (48%) in the world and contributes about 14% to total global output of 1012.5 million tonnes. Vegetables contribute 60.93% to the total horticulture production of India. With our current population of 1210 million and considering 25% post harvest losses and 5% export and processing, per capita availability of vegetables is about 230g per day which is reasonably below than 300g of recommended dietary allowance (RDA) suggested by Indian Council of Medical Research. With the projected population of 1330 million in 2020 and 1650 millions in 2050, we have to produce at least 190 and 240 million tones, respectively. With increasing focus on processing and exports, the production targets are likely to increase further, thus creating more opportunities for vegetable growers.

The course on “**Vocational Elective : Olericulture-I**” for Class XI students has been introduced with the following objectives:

- This is a basic course to apprise students regarding the importance of vegetable crops and different cultural practices to be followed for vegetable cultivation. Major topics covered in this book are importance and status of vegetable cultivation in India, classification of vegetables, role of environment and edifice factors in vegetable production, cultural and management practices in vegetable cultivation, role of macro and micro nutrients, growth regulators, training and pruning, post harvest handling and application of biotechnology in vegetable production. A complete package of cultural and management practices for solanaceous and cucurbitaceous vegetables have also been dealt in this book.
 - Students will get an exposure on vegetable production, which will motivate students to take up vegetable production as an avenue for self-employment.
 - This course is an effort to sensitize student in the field of vegetable production. The students will get an opportunity to choose career in the area of horticulture/olericulture.
- This course has been designed to provide entry level job skills to the students and will generate human resource in vegetable sector.

51 क. मूल कर्तव्य – भारत के प्रत्येक नागरिक का यह कर्तव्य होगा कि वह –

- (क) संविधान का पालन करे और उसके आदर्शों, संस्थाओं, राष्ट्रध्वज और राष्ट्रगान का आदर करे;
- (ख) स्वतंत्रता के लिए हमारे राष्ट्रीय आंदोलन को प्रेरित करने वाले उच्च आदर्शों को हृदय में संजोए रखे और उनका पालन करे;
- (ग) भारत की प्रभुता, एकता और अखंडता की रक्षा करे और उसे अक्षुण्ण रखे;
- (घ) देश की रक्षा करे और आह्वान किए जाने पर राष्ट्र की सेवा करे;
- (ङ) भारत के सभी लोगों में समरसता और समान भ्रातृत्व की भावना का निर्माण करे जो धर्म, भाषा और प्रदेश या वर्ग पर आधारित सभी भेदभाव से परे हों, ऐसी प्रथाओं का त्याग करे जो स्त्रियों के सम्मान के विरुद्ध हैं;

THE CONSTITUTION OF INDIA

PREAMBLE

WE, THE PEOPLE OF INDIA, having solemnly resolved to constitute India into a ¹**SOVEREIGN SOCIALIST SECULAR DEMOCRATIC REPUBLIC** and to secure to all its citizens :

JUSTICE, social, economic and political;

LIBERTY of thought, expression, belief, faith and worship;

EQUALITY of status and of opportunity; and to promote among them all

FRATERNITY assuring the dignity of the individual and the² unity and integrity of the Nation;

IN OUR CONSTITUENT ASSEMBLY this twenty-sixth day of November, 1949, do **HEREBY ADOPT, ENACT AND GIVE TO OURSELVES THIS CONSTITUTION.**

THE CONSTITUTION OF INDIA

Chapter IV A

FUNDAMENTAL DUTIES

ARTICLE 51A

Fundamental Duties - It shall be the duty of every citizen of India-

- (a) to abide by the Constitution and respect its ideals and institutions, the National Flag and the National Anthem;
- (b) to cherish and follow the noble ideals which inspired our national struggle for freedom;
- (c) to uphold and protect the sovereignty, unity and integrity of India;
- (d) to defend the country and render national service when called upon to do so;
- (e) to promote harmony and the spirit of common brotherhood amongst all the people of India transcending religious, linguistic and regional or sectional diversities; to renounce practices derogatory to the dignity of women;
- (f) to value and preserve the rich heritage of our composite culture;
- (g) to protect and improve the natural environment including forests, lakes, rivers, wild life and to have compassion for living creatures;
- (h) to develop the scientific temper, humanism and the spirit of inquiry and reform;
- (i) to safeguard public property and to abjure violence;
- (j) to strive towards excellence in all spheres of individual and collective activity so that the nation constantly rises to higher levels of endeavour and achievement;
- ¹(k) to provide opportunities for education to his/her child or, as the case may be, ward between age of 6 and 14 years.
